While officers were detaining S-1, S-2 (Sacramento resident) and S-3 (Elk Grove resident) returned to the suspect vehicle from a business in the shopping center. A records check revealed both S-2 and S-3 had active warrants out for their arrests. Further investigation also found S-2 and S-3 were in possession of V-1's debit card and had used it at a business. All three suspects were arrested and then transported to the main jail.
